Dear Residents

Last night, President Ramaphosa announced that the country would move back to lockdown level 3 as from midnight on Monday 28th December.

Although this is disappointing news for our economy, the rate of infection needs to be curbed - with more than one million confirmed COVID cases (50 000 new cases reported since Christmas eve) and nearly 27 000 deaths.

Infections are on the rise, in part because we are social beings and have a need to socialize with one another. Due to our concern for our Residents and those with co-morbidities we need to do our utmost to protect particularly our most vulnerable Residents and therefore the following has been decided and will remain in place until the 31st January.

Fleming House (Frail and Midcare) and Resthaven

We need to return to the most stringent levels of caution at Fleming House and Resthaven and therefore this means returning to complete lockdown for both these facilities. No visitors will be permitted, and only Essential Services will be allowed into these Care Facilities. Residents will not be allowed to go out unless it is for a Doctor/Hospital check up. Walking will be permitted outside, but only on the predesignated routes. Our staff will revert to staying on the site to mitigate their COVID risk.

Parcels can be dropped off at Security who will then deliver them to the Resident.

Estate Residents

Your family members will be able to visit, however we strongly advise that you limit all social activity to the absolute minimum. Please follow these rules and safety precautions:

Visiting at Randjes will only be allowed during daylight hours between 9am and 6pm daily and ideally should be held outside.

- ✓ You and your visitors must wear a mask during the entire visit (except when drinking or eating)
- ✓ No hugging or touching
- ✓ Stay 2 meters apart from each other during the entire visit

- ✓ Sanitise hands on arrival
- ✓ If you visit indoors have as many windows and doors open as possible
- ✓ Keep the number of visitors inside your home at any one time to a maximum of 4 (2 if you are in a 1 bedroom unit and 1 if you are in a bedsitter)
- ✓ Keep the visits as short as possible – no more than 1 hour is recommended - to limit possible virus exposure from visitors

We each have a responsibility to wear our masks, sanitize our hands and keep a safe distance from others.

Remember to avoid:

- Closed spaces
- Crowded places
- Close contact with others

Let's do whatever it takes to stay safe and to keep each other safe.
