In the event of a mental or physical disability, whether temporary or permanent, Randjes Estate retains the right to move a Resident to our Frail or Mid Care Accommodation, as detailed in our contract. This decision will be made at the discretion of Randjes Estate, in consultation with the Chief Executive Officer, Matron, a medical doctor, and the Resident's family. Independent homes are not permitted to have 24-hour home-based care, as our excellent Care Accommodation caters to Residents in need of assistance with activities of daily living.

Vacating the Accommodation

If a Resident wishes to vacate the accommodation, one calendar month's written notice is required.

Medical Costs

All Residents are responsible for their own medical costs and arrangements.
